



Navarro County Board of REALTORS® Memorial Scholarship Criteria & Guidelines

Criteria for Scholarship Applicants:

1. The applicant will be a high school senior currently attending a school in Navarro County.
2. The applicant will be required to submit a completed application provided by the NCBOR.
3. The applicant should be accepted to a college of their choice no later than April 30th of current year.
4. Enrollment with a minimum of 12 hours is required. If the recipient does not enroll in college during the same year as the scholarship is awarded, then the recipient forfeits the scholarship and no money will be disbursed to that recipient. Upon forfeiture of the scholarship by the first recipient, the scholarship will in turn be given to the alternate recipient. If an alternate recipient forfeits the scholarship no money will be disbursed.

The Scholarship Process and Guidelines:

1. Applications will be distributed to each High School in Navarro County. The application will be available online through the NCBOR website. The application link will be posted on social media.
2. The submission and postmark deadline for these applications will be April 1st of each year.
3. The Executive Board will first consider applicants related to board members that meet the criteria determined by the board.
4. The Navarro County Board of REALTORS® Memorial Scholarship will be set at not less than \$500 total per year. Money forfeit from a previous year will roll over and increase the amount of the scholarship for the next year which will be given to one or more recipients at the discretion of the Executive Board.
5. It will be the duty of the current presiding board President to appoint a Scholarship Committee to be in charge of distributing applications to interested members and county high schools. The President can request that any application be reviewed by the officers and directors.
6. If a NCBOR member has a relative that has turned in an application for scholarship they will be excused from serving on the selection committee.
7. Each application should be sent to the Chairperson and the office address included on the application.
8. The recipient/s and, if available, an alternate recipient will be approved by the officers and directors of the Navarro County Board of REALTORS® no later than the May BOD and General Meeting date.
9. The recipient/s will be notified and a scholarship certificate will be presented, if possible by the NCBOR Scholarship Committee Chairperson, at the May NCBOR General Meeting. The President can appoint another Executive Board member to make the presentation.
10. Upon the recipient's enrollment the scholarship funds will be sent to the recipient's school.
